# 7.2 Rapid Testing Motion

Roundtable was held amongst executive members to discuss access to rapid tests. Concern from parents and students around lack of information and access to positive cases. The rapid testing program is available from the Government of Alberta if you have vulnerable people, essential workers, amongst other criteria. Felt that certainly we meet this criteria. Liz Kohle was able to provide information that the division has been approached on this and that rapid testing was previously piloted, considering to make available again. Being piloted currently in Morinville Public. Potential for it to be rolled out at a later point to include access to home testing kits for students. Discussion was held around whether our council would support a vaccine mandate for teachers. Various viewpoints were shared around whether or not this should be mandated. Further discussion around the change in circumstances from time when this was previously piloted as the isolation rules related to close contacts required isolation and testing. Whereas now isolation is not required for close contacts access to this would seem beneficial.

Jared motioned the following to be presented to the Board of Trustees as a whole: The Bon Accord Community School Council supports the Sturgeon Public Schools Board of Trustees to take all necessary steps to enroll Sturgeon Public Schools in any Rapid Testing Program offered by the Government of Alberta.
