# a. <u>Chair</u>

Fundraising surpassed our \$10,000 goal, with our three fundraisers which have been so great, maker space stuff, snow shoes, \$200 per classroom budget for each teacher. In terms of fundraising I would recommend sticking with the three fundraisers, January, February and March we will have casino night for next year, Lillian Schick just got their date for December. We hope to get one in the new year, we will be looking for volunteers with the casino. Will need 15 key volunteers. As soon as we get the date for the casino, then have to secure top 5 volunteers for the casino. Look to fill the rest of the volunteer positions after. The society, will be able to apply for the casino date every 2 years now. Will have to get a separate casino bank account, as well as some other parameters for using the casino, such as sending planned projects etc. PSS will have to decide if they use an advisor for the casino event.

Usually we have 100 kids signing up, we had 164 pizzas ordered last week, including some staff and administration, 170 hot dogs this week. Hot lunch continues to be a success, we are still hoping, will wait and see if there is a day in June.
